

1. What is this Privacy Policy for?

This Privacy Statement applies only to www.bresist.com and www.bresist.be webpages. B-Resist is a privacy conscious consulting company. This Privacy Statement explains how we protect visitors' information gathered via this Website. The policy sets out the different areas where user privacy is concerned and outlines the obligations & requirements of the users, the website and website owners. Furthermore the way this website processes, stores and protects user data and information will also be detailed within this policy.

2. The Website
